# COMPETITION OVERVIEW

## Governance

**WADCC** governs the *Male Premier Cricket Competitions* with administrative support from WA Cricket.

**WAFCC** governs the *A & B Grade Female Premier Cricket Competitions* with administrative support from WA Cricket.

**WA Cricket** governs and administers the *Female Premier Cricket Youth League Competitions*.

## WA District Cricket Council (WADCC)

### WADCC Vision Statement

To deliver an environment for the State's best cricket talent, management, coaches, facilities & officials.

### Objectives & Strategy

The objects of the WADCC are to:

- Develop, organise, promote and administer the Competition with the support of the WA Cricket in accordance with the Cricket Council Rules in force from time to time;
- Provide an established pathway for players who participate in the Competition to be selected in State or National representative squads or teams;
- Encourage increased participation by both players and volunteers in the Competition;
- Administer the functions, powers and responsibilities that may be delegated to it from time to time by the Board of WA Cricket; and
- Provide leadership to and encourage relationships with all associations affiliated with the WA Cricket and all other persons, groups and associations involved in the playing or administration of Cricket.

The WADCC signs an affiliation agreement with WA Cricket annually that establishes WA Cricket's financial & administrative support of WADCC as an independent affiliate body. All clubs also sign an annual Membership Agreement to retain membership of the WADCC, which gives them benefits & privileges under the constitution, including participation in the competitions, access to grants & resources, administrative support and voting rights in council administration.

## WADCC Management Committee

The Management Committee is responsible for overseeing the day-to-day management of the competition in accordance with the WADCC Constitution & affiliation agreement with WA Cricket for both senior & junior competitions. The Management Committee is also responsible for creating strategy & policy for the Council, providing reports to WA Cricket & clubs for strong, well-balanced cricket competitions and financially viable best quality cricket clubs in Perth metropolitan area. All Management Committee members shall be delegates of the WADCC. The Management Committee consists of:

## WADCC Premier Club Delegates

Membership of the Council is open to each Premier Cricket Club. Each member club is represented at the District Cricket Council by a member of the relevant club that acts as a Delegate. Each delegate is entitled to a vote at all Annual General Meetings & Special General Meetings. The delegate is also expected to attend quarterly full-council meetings and represent the club in all matters relevant to operation of the competitions.

## WADCC District Junior Competitions Committee Delegates (DJCC)

The District Junior Competitions Committee (DJCC) is a sub-committee of the WADCC that reports to the full-council or the Management Committee at their meetings. - represent the interests of the Competition and its cricketers;
- oversee and, as appropriate direct (with the support of resources of WA Cricket), the administration of the WA Female Premier Cricket Competition including playing conditions, rules and by laws; and
- make recommendations on persons associated with female cricket for WA Cricket related or community honours.

# COMPETITION ADMINISTRATION

## Administration Guidelines

### Pre-Season Tasks

- The 2024-25 Premier Cricket Season starts on 1<sup>st</sup> July 2024, with all players deregistered.
- Complete **Club Return Forms, Membership Agreement & Financials** for prior season and return by 16<sup>th</sup> August 2024.
- Submit the initial **First Grade Player Points Cap** Form for approval by 20<sup>th</sup> September 2024. Furthermore, submit any new player points throughout the season as required.
- Obtain **Certificate of Currency** from Marsh Insurance (see *PlayHQ Administration* below).
- **Player Registrations & Transfers** open. Clubs are required to set up 'Participant to Club' Forms for all competitions for self-registration of players.
- Send any new **Uniform Designs** for approval prior to ordering.

### Australian Cricket Child Safety Framework

All club personnel involved in any junior teams or with junior players in an official capacity, including the Club President and other committee members, are required to hold a valid Working with Children Check. Additionally, The Child Safety Policy demonstrates WADCC's commitment to supporting parents & guardians in protecting and safeguarding children & young people.

Australian Cricket Child Safety Framework provides information and guidance about all relevant requirements and best practices to ensure a robust system is in place to create a secure environment for all children & youth.

## PlayHQ Administration

### Certificate of Currency

Below is a step-by-step process on how to set up your insurance and obtain your certificate of currency:

Step 1: Head to the Marsh Insurance Website [here](#).

Step 2: Select Cricket Australia and enter your State and Club Name

Step 3: Select 'Please Complete' under Risk Management and complete the Online Risk Management Module

Step 4: Once completed, you will be able to download your Certificate of Currency

### Player Registration and Allocation

Player Registrations and Transfers open on 1<sup>st</sup> July each year. Clubs can accept new player registrations or apply for transfers in PlayHQ from this date.

## [How to Self-Register \(Player\)](#)

As part of the self-registration process, participants will need to link their existing CricketID (associated to an email address). This ID must be the same login email that the participant uses to log into the PlayCricket app (previously MyCricket) or cricket.com.au app. If a participant does not have a CricketID, they will be prompted to create one. This will need to be linked to the participant's PlayCricket/MyCricket profile.

## [CricketID – Profile Claiming](#)

Once players have registered to the competition, the club is required to allocate players into relevant teams in various grades/competitions.

## [Allocate Participants to Teams](#)

### **Player Transfers**

Player Transfers can be applied for through the 'Transfers & Permits' page in the PlayHQ Admin site for any **existing players**.

For transfers that involve returning players who **did not** play last year, clubs must apply for a player transfer through the below form as that player would be new to the PlayHQ system.

## [Player Transfers Application Form](#)

The Cricket Operations Unit will manage the interim process via emails between clubs. The Club will then be notified once a transfer application is finalised, allowing the player to be able to self-register for that club if approved.

### **Overseas Player Dispensations**

All Overseas Players must obtain a one-year dispensation from the Competitions Manager to play in any senior matches. The dispensation is to be applied by the players' club of choice via the [Player Movement & Dispensations Form](#). Cricket Operations Unit will review and process the application's accordingly. Once approved, the players will be required to self-register for their club.

An overseas dispensation will expire at the end of the season unless terminated earlier with the consent of the club. At expiry of the dispensation, the player will remain registered with the club and will either need to re-apply the following season to play for the club or require a transfer as per General Rules 6.3 to play for another club.

No club may play more than 1 overseas player in male competitions, or 2 overseas players in female competitions per match, unless prior written approval is obtained.

### **Team Lists Submission**

For Male Premier Cricket, all clubs shall enter their team lists in PlayHQ no later than 10am on the Friday prior to the start of a match.

For Female Premier Cricket, all clubs shall enter their team lists in PlayHQ no later than 5pm on the Friday prior to the start of a match.

Teams must also be nominated in writing to the opposition team & umpires before the toss.

### **Player Movement Dispensations**

#### **Male**

Player Movement Dispensations apply to WADCC General Rules 5.3.5, 6.7 & 6.8.

A Representative Player may be replaced in a team list under Rule 5.3.5 if they are known to become available/unavailable on either day prior to the start of a match. They should be named on the team list along with the player that will be replaced. The Competition Manager should be notified via the [Player Movement & Dispensations Form](#) no later than 10am the day prior to start of the match. The captain shall notify the opposition & umpires prior to start of first day's play.

If a representative player becomes available/unavailable after start of play, a 'like-for-like' replacement/player movement may be named. The Captain shall notify the opposition & umpires prior to start of the day's play. Per Rule 6.7.1, unless approved by WADCC, no player who has played in 8 or more matches in any grade may play in a lower grade of the senior competition during the remainder of season.

No player may play more than one grade lower than the highest grade they've played in during the season, unless prior written permission is obtained.

In addition to above, Finals Eligibility criteria applies to all players participating in finals as per

Rule 6.8, a summary of which is set out in the table below:

Grade	Qualification
Senior Grades Competitions	5 Matches in that Grade, or a cumulative total of 5 matches across that Grade and/or any lower grades
Senior T20 Competitions (Premier T20 & Colts)	Player must be registered with the club on or before 31 <sup>st</sup> December of the current season.
Junior Grades Competitions	3 Matches in that Age Group or 3 Matches in a Lower Age Group. Clause 6.6.2 continues to apply.

## Female

Player Movement Dispensations apply to WAFCC General Rules 6.7 & 6.8.

Under Rule 6.7.1, unless approved by the Competitions Manager, no player who has played with any grade of the Senior Grade Competition in five (5) or more matches shall be allowed to play in a lower grade of the Senior Grade Competition match during the remainder of the Season. T20 and One Day competitions are deemed as separate in these circumstances.

Under Rule 6.7.2, a player who holds a professional contract in an Australian Domestic Cricket Competition is only eligible to play in the A Grade 50 Over and A Grade T20 Competitions.

Under Rule 6.7.3, when a Club's higher-grade team has a fixtured 'Bye' or 'Forfeit' and three (3) or more higher-grade players are selected to play in a lower grade, no more than two (2) of them are permitted to return to the higher grade after playing one match in the lower grade. The remaining players may be promoted after having played at least two matches in the lower grade.

In addition to above, Finals Eligibility criteria applies to all players participating in finals as per Rule 6.8 which states a player must play in at least 3 matches in the grade for which they are playing in the final, or at least 3 matches for a lower grade.

## Captain's Reports

Both club captains in all matches are required to submit a Captain's Report by Monday 5pm following the conclusion of the match.

Captain's Reports are to be completed through the OfficialsHQ platform and can be found via a web link sent to the captain's email address at the conclusion of their respective match.

Please note that captains must be listed correctly within the team list on PlayHQ prior to the match for the link to be sent to the correct player.

## PlayHQ Live Scoring & Scores Submission

All clubs are required to use the PlayHQ E-Score system for live electronic scoring in all Male First & Second Grades and Female A Grade matches.

Clubs are also highly encouraged to use live-scoring or electronic scoring via PlayHQ E-Score for all matches in other senior & junior grades for their convenience.

### [PlayHQ E-Score](#)

*This link is compatible with all web browsers and can also be set up as an app icon in Android and IOS systems.*

In case live/electronic scoring isn't utilised, all match scores & results must be uploaded in PlayHQ no later than 7pm the day of the match.

Match Results and Player Scores can be uploaded into PlayHQ through the admin website.

## Premier Club Grants

The Premier Cricket Club Grants for 2024-25 season have been structured as below:

- Base Sum Distribution – August 2024
- Part 1 is due on Friday, 27<sup>th</sup> September 2024 at the latest (*refer to individual criteria deadlines*).
- Part 2 is due on Friday, 28<sup>th</sup> February 2025 at the latest (*refer to individual criteria deadlines*).

Assessment of all submissions along with issuance of Purchase Orders will be made as soon as possible after the due dates. Please allow up to 30 days after invoice submission for the payment to be processed.

# MATCH OVERVIEW

## Competition General Rules & Playing Conditions

All the relevant General Rules & Playing Conditions can be found on the WA Premier Cricket website [here](#).

### Match Balls

See Clause 5.6 in the General Rules for approved Match Balls for all Grades. Please note that for the 2024-25 Premier Cricket Season, only Kookaburra balls are to be used as Match Balls in all grades.

### Age & Gender Eligibility

#### Male

A player must not play or act as a substitute player in a Senior Competition unless they are at least 14 years old on 30<sup>th</sup> June immediately preceding the season.

General Rules 6.6.2 provides information on Junior Players Age Eligibility in relation to the age cut-off date.

A female player may be allowed to play in a male WADCC competition upon the club receiving a dispensation prior.

#### Female

Players are only eligible to play in A & B Grade if they are 16 years old as of 31 August immediately preceding the Season, as per clause 6.6.1 of the WAFCC General Rules. Approval will be considered for players 15 years of age as of 31 August 2024. In exceptional circumstances, players 14 years of age may be considered.

The *Premier Cricket Age Dispensation Request* criteria can be found [here](#). To apply for this dispensation, please refer to the [Player Movement & Dispensations Form](#).

Players are only eligible to play in the Youth League Competition if they fit within the following requirements as per clause 6.4.1 of the Youth League General Rules:

**Under 17's** – older than 13 years but younger than 17 years

**Under 14's** – older than 11 years but younger than 14 years

### Player Disqualification

A player serving a suspension or disqualification to play issued by the Competitions Manager, WADCC, WAFCC, the Tribunal, Cricket Australia or any other affiliated association of WA Cricket or Cricket Australia is automatically disqualified from participation in any competitions for the duration of that suspension or disqualification.

If the council is satisfied on complaint that a player has participated in a match during their suspension or disqualification period, the club may be liable to a fine and/or loss of match points as per infringements schedule in WADCC General Rules Clause 4.16, WAFCC General Rules Clause 4.15 or Youth League General Rules Clause 4.14.

### Club Facilities

Scoreboards (electronic/manual) shall be provided for all matches. For Male First Grade & Female A Grade matches, a scoreboard operator must be provided by the home club to update the scoreboard at least at the end of each over.

All clubs are required to provide bowling markers, pitch covers, crease markings & marking materials to the satisfaction of umpires, a set of stumps (6) with bails, boundary markers, cones, ropes & Duckworth-Lewis Score Calculators (where applicable) in all home matches.



Additionally, in First & Second Grade matches in the Senior Competition, a Sightscreen of appropriate colour (white for red-ball matches & black for white-ball matches) and size shall also be provided by the home club.

All clubs are also highly encouraged to sweep & remark the crease markings at scheduled intervals during play.

## Standard Cricket Attire

### Male

Unless otherwise specified in relevant playing conditions, players must wear predominantly white cricket clothing. Caps & Helmets must either be of the club colours or white only (unless otherwise agreed by captains if no other helmet is available). Spiked footwear must be worn at all times while on the field. General Rules 8.1.2 & 8.1.6 provide information about sponsor logos positioning and size restrictions.

### Female

For all Female Premier Cricket Competition matches, playing attire must be coloured playing kit. The colours must be the approved colours of that Club, in a uniform design approved by WA Cricket. Players are also able to have names on the back of their playing shirt, however nicknames are not permitted. Rule 8 of the General Rules dictates playing attire requirements (inc. sponsors logos).

## Male First Grade Player Points Cap

All First Grade Teams in a WADCC Senior First Grade Competition (two-day or limited overs) shall comply with a Player Points Cap of 25 points per team.

A non-overseas player who makes his first grade debut at a club shall attract 1 point when playing for that club.

If a non-overseas player that makes his first grade debut at a particular WADCC club (or an interstate Premier Club in Australia) moves to another WADCC club, they shall attract 1 point only when playing for the other club provided they have not played more than 5 games in a First Grade competition with any Premier Club in Australia at the time they moved.

The table in General Rules clause 9.1.5 sets out criteria for the status of all players moving to other clubs or playing for a particular club and the relevant point values they may attract. When a player's Points Value at a club is 3 or more, the value shall reduce by one point for each consecutive season of service at the club to a minimum of 2 points. A player that moves clubs and remains at the club he transferred to for five consecutive seasons, shall attract one-point value in the subsequent season.

If a player is deemed to fit in more than one category for points allocation, they must be allocated the category that attracts the highest points value.

A Replacement Player is deemed to have the same points value as the player they're replacing in a match.

Any non-Australian citizen or permanent resident that is classed as a 'Local Player' in the definitions under 1.1.1(k), shall attract the same Player Points as defined under the 'Players from other Countries' category in clause 9.1.4 above.

## Ladders Calculation

In all senior & junior competitions, all points gained from any match formats played in that grade shall be counted towards the ranking in the relevant grade. All match point allocations will be listed in a grade's respective annexure.

To determine the ranking of teams otherwise on equal points, the Quotient calculation method will be used for all Senior Male competitions (excluding First Grade One-Day League Ladder, Premier T20s & Colts League).  
(Total Runs Scored/Total Wickets Lost) / (Total Runs Scored Against / Total Wickets Taken)

To determine the ranking of teams otherwise on equal points, the Net Run Rate calculation will be used for Male First Grade One-Day League, Male Premier T20 & Colts League competitions, Senior Female and all Junior competitions.  
(Total Runs Scored/Total Overs Played) / (Total Runs Scored Against / Total Overs Bowled)

## Club Championship

The Male & Female Premier Club Championship points will be awarded to each club during non-finals rounds, based on points earned in each grade of the Senior competitions.

The ladder points for each grade will be used for calculation, multiplied with weighting factors as:

## Wet Weather Procedures

General Rules 5.7, 5.8, 5.9 (only 5.7 for WAFCC) refer to the Ground, Weather & Light procedures & partial cancellation of matches.

[Extreme Weather Policy](#) provides information around Heat, Lightning & Thunderstorm procedures.

Clubs must advise the Competitions Manager no later than 12 PM on the day prior to a competition fixture if there are significant problems being experienced in pitch & ground preparation due to inclement weather.

Clubs are required to use covers for the entire area of all the turf pitches in their turf pitch block, including the ones not being prepared for use as per the covers directive issues by the Competition Manager. The clubs must also provide accessibility to covers for use prior to & during the match day(s).

All matches will proceed ahead with the clubs expected to host & players expected to show up to the matches unless the Competitions Manager has called off the round or a fixture on the day prior to the scheduled fixture. If there is no general cancellation, umpires must determine the fitness for play at all matches.

The WADCC/WAFCC may call off all fixtures in any grade (excluding Female Youth League) up to 2 hours before the scheduled start of play if more than 50% of the grounds in that grade are unfit for play. Cricket Operations Unit may call off all fixtures in any Female Premier Youth League Competitions by 8pm the evening prior to a scheduled round of fixtures, if more than 50% of grounds are unfit for play.

The [WA Premier Cricket Wet Weather Page](#) provides status of all the fixtures, covers directive & relevant Rules.

## Code of Conduct, Reporting & Tribunal Procedures

WADCC, WAFCC and Youth League General Rules, Clause 4, details the Spirit of Cricket and Code of Conduct & Offences along with relevant penalties, Protests, Reporting and Tribunal procedures. WADCC and WAFCC General Rules 4.5 and Youth League General Rules 4.4 also govern *Use of Social Media*.

## Reporting & Tribunal Procedures

Upon a breach of Code of Conduct, Umpires must notify the club, player or an official of any intention to lodge a code of conduct complaint within 60 minutes of the stumps being drawn on the day of the alleged offence.

The umpire must then lodge a **Code of Conduct Complaint** with the Cricket Operations Unit no later than 12 noon on the Monday following competition of the match. Failure to comply



does not automatically invalidate the complaint. The reported player/official's complaint must be referred to the Disciplinary Committee, who shall determine the level of offence & offer a penalty or refer the matter to tribunal.

An **Offer of Penalty detailing Statement of Findings or a Notice of Tribunal Attendance** is communicated by the Cricket Operations Unit to the relevant club no later than 5 PM on Monday following the conclusion of the match in which the offence has occurred.

A notification of **Acceptance/Rejection of Offer of Penalty** must be communicated by the club to the Council/Cricket Operations Unit no later than 12 PM on Tuesday following the conclusion of the match in which the offence has occurred.

A signed **Offer of Penalty** must be submitted as soon as feasible. A club official may sign the Offer of Penalty on a player's behalf.

If the Offer of Penalty is rejected, A **Statement of Defence** must be submitted by the player/official via the club no later than 5 PM on Tuesday following the conclusion of the match in which the offence has occurred. This Statement of Defence shall be in response to the Statement of Findings and will be passed on to the independent Tribunal for final adjudication.

**Tribunals** are usually held on Wednesday nights 6 PM at the WACA Ground unless advised otherwise. The WACUA appoints an Umpires Support Person every season that is available for consultation, advice, support and representation in all disciplinary matters & tribunal hearings. The umpires are encouraged to contact the Umpires Support Person should they wish to seek any support in code of conduct proceedings.

## Umpiring & WACUA

All WA Premier Cricket umpires are required to be accredited through the Cricket Australia Umpires Accreditation Program with most umpires holding a Representative level accreditation. All umpires also are required to have a valid Working with Children Check to be able to officiate in any Premier Cricket matches. Regular training, development & mentoring support is provided to all Premier Cricket umpires through WA Cricket.
